

# Terms and conditions prize draw Public Health Monitor Young Adults 2024



## Terms and conditions prize draw Public Health Monitor Young Adults 2024

1. These terms and conditions apply to the prize draw for the Public Health Monitor Young Adults 2024 questionnaire and campaign, organised by the 25 regional GGDs, the public health department of the municipality of Utrecht, GGD GHOR Nederland, and RIVM. The questionnaire and the prize draw are run by Ipsos I&O.
  2. Participation in the prize draw is possible between 8 April 2024 and 7 July 2024.
  3. Participation in the prize draw is possible by taking part in the questionnaire of the Public Health Monitor Young Adults 2024 via [www.jongerenmonitor.nl](http://www.jongerenmonitor.nl). Ipsos I&O is responsible for the prize draw.
  - 4a. The following prizes are included in the prize draw:
    - 600 [Keuze Cadeaukaart](#) gift vouchers of €25
    - 10 [Keuze Cadeaukaart](#) gift vouchers of €400
  - 4b. At the end of the survey, the respondent indicates whether they want to qualify for winning a gift voucher. The respondent must therefore complete the questionnaire to have a chance to win a gift voucher.
  - 4c. Among respondents who indicate that they want to have a chance to win a gift voucher, the winners are chosen at random, using an automatic script. This draw takes place for each respondent separately, with a 0.01% chance of winning a €400 gift voucher, 0.67% chance of a €25 gift voucher, and a 99.32% chance of no prize. A quota has been implemented to prevent too many gift vouchers from being raffled. If the quota of a gift voucher has already been reached when a respondent participates in the draw, that gift voucher will be excluded from the draw. To prevent the scenario where not all gift vouchers are raffled, either due to randomness of the draw or due to a response lower than 90,000, the chance of winning can be adjusted during the study. If respondents have won a gift voucher, they will immediately be notified hereof on the screen and they will be asked to enter an email address (and also a telephone number, in case of the €400 gift voucher) so that Ipsos I&O can send the gift voucher digitally. If a respondent has not won a gift voucher, this is also immediately shown on screen.
  5. A maximum of one entry per respondent is permitted. Double email addresses and telephone numbers will not be eligible for the gift vouchers.
  6. Prize winners will be contacted by Ipsos I&O within a week after winning a gift voucher via the email address provided by the respondent (and via telephone in case of the €400 gift voucher), to receive the gift voucher.

7. To participate in the prize draw, respondents must enter their email address (and telephone number, in case of the €400 gift voucher) at the end of the questionnaire. Winners who have not completed the necessary contact information are not able to receive a gift voucher. The personal data (email addresses and/or telephone numbers) of the winners will not be used for marketing or any other purposes and will be deleted once the prizes have been awarded. The personal data will be stored separately from the questionnaire data and cannot be matched to the rest of the completed questionnaire.
  8. Gift vouchers are not offered in cash and are non-transferable.
  9. Respondents must be between 16 and 25 years old and must be a resident in the Netherlands at the time of completing the questionnaire.
  10. Respondents younger than 18 years old are only eligible to win a prize once permission has been obtained from their parent(s) or carer(s). GGD GHOR Nederland cannot however be held liable in any way for ensuring compliance with this. GGD GHOR Nederland reserves the right to ask respondents under the age of 18 to provide contact details of their parent(s) or carer(s) in order to obtain their consent for receiving a prize.
  11. No gambling tax is due on the gift vouchers that are paid out.
